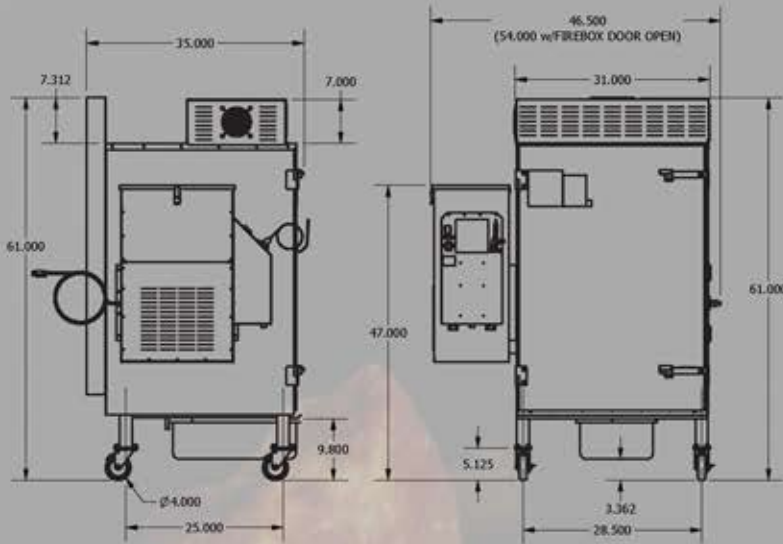

FEC120 Venting Requirements

Before installation, contact local code officials and a commercial kitchen ventilation contractor to determine codes and permit requirements. Unit must be installed per state and local fire codes and meet NFPA 96 in the US. The unit requires a separate 120 volt, 20 amp circuit and grounded in accordance to the National Electric Code ANSI/NFPA 70-1990 (or comparable codes outside the United States). The Fast Eddy' s™ by Cookshack FEC120 and FEC240 must be installed under a commercial hood with fire suppression applicable to local code (NFPA 96). Adequate makeup air is required for safe operation.
